JAL Hotels Co., Ltd. Will Open Five-Star Hotel Nikko Wuxi In Wuxi, China, in 2010

Tokyo – JAL Hotels Co., Ltd. (Headquarters: Shinagawa-ku, Tokyo; President: Mamoru Tsutsumi) announced that the company has jointly signed a hotel management agreement on October 20, 2007 with its joint-corporation in China, BTG Nikko International Hotel Management Co., Ltd. (Headquarters: Beijing, China; Chairman of the Board: Yang Jin Shan), and Wuxi International Business Center Co., Ltd. (Headquarters: Wuxi, Jiangsu Province, China; Chairman of the Board: Huang Kan) to open Hotel Nikko Wuxi in 2010. The hotel will be located Wuxi, Jiangsu Province, China.

Hotel Nikko Wuxi will be built along an old canal, which is going to be listed as a UNESCO World Heritage site, in the Nanchang District of Wuxi. It will be a five-star-class, international hotel with 500 guest rooms in a 16-story building, which will occupy a total of 61,109 square-meters. The hotel's facilities will include Japanese, Chinese and buffet restaurants, a wine bar, banquet rooms and meeting rooms. The hotel intends to be a focal point for the local Wuxi culture with a mixture of Chinese heritage and Japanese hospitality. From the center of Wuxi, it is a five- to 10-minute-drive to the hotel, which is in a prime location for both business and leisure.

Wuxi, a cosmopolitan city with a population of over 4 million, is located along the lower Chang Jiang River (also called Yangtze River) in the eastern part of China. More than 1,000 Japanese companies have set up their offices in Wuxi, and therefore, a number of Japanese business people reside in or travel to the city. With Lake Taihu in the south, Chang Jiang River in the north and canals traversing the city, Wuxi is also a tourist destination, offering canal cruises, historical and cultural monuments and temples, gardens and parks with magnificent views. Located 120 km from Shanghai and 180 km from Nanjing, Wuxi is also conveniently accessible from other major cities in China.
